8. Performance of teams and preparation for the Olympic Games

Secretary General requested CEO to provide an update to the House on the performance of the teams and preparations for the Olympic Games.

The CEO informed that unfortunately due to the Covid-19 pandemic that neither of the Indian senior teams have been able to have any international competition since February 2020. The Members were advised that we are fortunate that the teams are in a bio-bubble at SAI Centre Bangalore and are able to resume full training since August 2020 in a safe and secure environment.

The Annual Calendar for Training and Competition (ACTC) has been submitted to SAI in August 2020 and October 2020 for all four national teams for a period up to 30 September 2020. After an initial meeting with SAI and MYAS, the schedules for the teams has been provisionally approved, however due to the global pandemic the schedules are likely to continue to be revised. CEO assured the House that Hockey India staff along with the respective Coaches are reviewing the situation on a weekly basis and looking at various back up options incase the current scheduled tournaments / matches are unable to be fulfilled due to country restrictions due to Covid-19.

The House wished to place on record their gratitude to MYAS and SAI for the support of Hockey India and especially for the athletes in ensuring that they are trained in a secure environment.

CEO further advised that there are two current major vacancies with the senior programme, that being the Director High Performance and Analytical Coach with the Senior Men Team. CEO advised that the two roles are currently being advertised for a period up to Olympic Games 2021.

Consideration of Annual Hockey Calendar as presented by CEO

9.1 Calendar for the National Teams

Secretary General informed the House that Hockey India has submitted the Annual Competitions and Training Calendar (ACTC) for the Indian Hockey Teams for the period 1 April 2020 to 30 September 2021 to Sports Authority of India. The ACTC was submitted after detailed discussions between the Chief Coaches for each Men and Women and Director High Performance.

Secretary General requested CEO to provide the details to the House.

CEO provided the detail of the Tours and Camps scheduled in the ACTC and updated accordingly. CEO further informed the House that all the details were provided on the Hockey India website and encouraged Members to review the website for details and results of the teams activities.

The detailed plans of each of the teams have been scheduled keeping in mind the preparation of the Indian Senior Men and Women Teams for the Olympic Games 2021 and Junior Men and Women World Cup 2021. CEO advised that the qualification for the Senior Men and Women Teams were still valid although the event has been rescheduled to 2021. For the Junior World Cup, since India is the host for the Junior Men World Cup in 2021 the Indian Junior Men team has automatically qualified, however the Indian Junior Women team have to come in the top 3 at the Junior Women Asia Cup which is currently scheduled for April 2021.

CEO informed the House that the below plans have been provisionally approved by MYAS and SAI however some of the international tournaments are still tentative and subject to the confirmation on the final dates of each of the tournaments due to the Covid-19 pandemic.

The House discussed in detail to the programme for each of the national teams for 2020-21.

REPORT OF THE RETURNING OFFICER OF ELECTIONS OF HOCKEY INDIA FOR THE POSTS OF PRESIDENT AND SENIOR VICE PRESIDENT HELD ON 06TH NOVEMBER 2020

Hockey India vide its letter dated 08th October 2020 informed undersigned that the Secretary General of Hockey India desired to ascertain my convenience to be the Returning Officer for conducting the elections of Hockey India for the posts of President and Senior Vice President. The elections were proposed to be held on 06th November 2020 at Crystal Ballroom of Hotel The Lalit, Barakhamba Avenue, Connaught Place, New Delhi-110 001 along with the meeting of the 10th Congress of Hockey India. It was also indicated that the elections are to be held as per the constitution of the Hockey India and Election Bye-laws to Rule 4.3 Updated as at 05.10.2020.

- 2. I agreed to the request of the Hockey India and also their terms and conditions. Subsequently after my acceptance, a copy each of the following documents was also provided to me:-
 - 1. Notice dated 9th October 2020 issued by the Hockey India indicating time lines for the elections and inviting the nominations for Electoral College.
 - 2. Copy of e-mail of Notice sent to Permanent Members of Hockey India.

- 6.
