## **Hockey India (HI):**

It is recognized by the Ministry of Youth Affairs & Sports, Govt. of India as the sole body responsible towards promoting Hockey in India. Hockey India is regularly conducting the Domestic Event/Zonal/National Championships in the different states.

# 2. Request for Proposal

Hockey India invites proposal from eligible and reputed firms on Hockey India E-Tender Portal <a href="www.hockeyindia.org/tenders">www.hockeyindia.org/tenders</a> to provide Branding Services for all matches of Domestic Event/Zonal/National Championships scheduled to be held in the financial year 2024-25. # Submission / Opening of Proposals

- 6. The valid GST Registration should be mentioned on the quotation. The bidder must enclose the below documents with proposal:
  - (i) A copy of GST certificate
  - (ii) A copy of self-attested PAN Card.
- 7. The bidder shall submit their proposal on the e-tender portal www.hockeyindia.org/tenders only as per the schedule. The proposals that are submitted beyond the stipulated date and time under any circumstances whatsoever will not be considered.
- 8. **Earnest Money Deposit:** No earnest money deposit required.

- 9. Proposals will be opened by a committee on due date and time. Authorised representative from your firm may attend the proposal opening. If due to any exigency the due date for opening off proposal is declared as closed holiday, in such cases the proposals will be opened on next working day at the same time or any other day/time as intimated by Hockey India.
- 10. The proposals should be uploaded on the e-tender portal <a href="https://www.hockeyindia.org/tenders">www.hockeyindia.org/tenders</a>, latest by <a href="https://www.hockeyindia.org/tenders">11:00 Hours</a> on 30 April 2024. The proposals would be opened by a Committee at 14:00 Hours on 30 April 2024.
- 11. Proposals sent by FAX, Email, or unsealed proposals will not be considered. The proposals uploaded on the e-tender portal <a href="www.hockeyindia.org/tenders">www.hockeyindia.org/tenders</a> will only be considered.

To avoid any complications with regard to Late Receipt/Non Receipt of Proposals, it may please be noted that responsibility rests with the bidders to ensure that proposals uploaded on the e-tender portal <a href="www.hockeyindia.org/tenders">www.hockeyindia.org/tenders</a> on or before due date and time. Late proposals will be rejected out rightly.

- 12. In case your firm is not willing to quote due to any reasons, your regret should be emailed well before the due date failing which your firm can be de-listed from our vendor list.
- 13. The commercial offer must be firm and valid for all Hockey India Domestic Events/Zonal/National Championships conducted for the financial year 2024-25 till completion of the event from the date of proposal submission.

# **Commercial Aspects**

- 14. Prices must be quoted on F.O.R. Destination basis by road inclusive of Packing, Forwarding, Freight charges, Transit Insurance and any other charges as applicable. The consignee for the contract is <u>Hockey India</u>.
- 15. GST/IGST would be charged separately and should not be included in the rates.
- 16. <u>Liquidated Damages (LD):</u> Preference shall be given to those offer supply within the prescribed delivery schedule, which shall be the essence of the contract Liquidated Damage @ 5% per week subject to a maximum of 10% of the undelivered items will be recovered in case of delay in delivery beyond the accepted delivery period as per SCOC.
- 17. The Commercial Offer will be opened by a Committee and if firm desires, may depute their representative, to be present at the time of opening of proposals. Further negotiations will be only with the lowest bidder (L1) who would provide the services.
- 18. Work to be commence as per the work order /direction provided by Hockey India to the lowest (L1) bidder. (This can be changed based on nature of urgency of services required).
- 19. The Payment will be made within two weeks after completion of each event subject to submission of original tax invoice or as per the decision of the purchase committee of Hockey India.

- 20. On receipt of the consignee's premise, the items are to be checked for ascertaining the correctness of quality and quantity. If there will be any discrepancy that will not be acceptable and order would be cancelled.
- 21. The Lowest 'Acceptable' proposal shall be considered further for placement of Contract/Work Order after complete clarification and price negotiations if applicable.
- 22. This RFP is being issued with no financial commitment and Hockey India reserves the right to change or vary any part thereof at any stage. Hockey India also reserves the right to reject any/all proposals including the lowest one without assigning any reason.
